This is a statement of facts

I, *Reverend (hereinafter Rev.) Cindy Falco* aka *Rev. Cindy Falco- Di Corrado* with domicile at 316 N.W.1st Avenue, Boynton Beach, Florida; Phone: 904-501-3082 as one People of "We The People" in Sui Juris with all due respect, within the best way to proceed, with the truth, the whole truth, and nothing but the truth, not misleading, declares as follows:

Rev. Cindy Falco – Di Corrado, has been doing outreach ministry most of her life. An Ordained Minister (**See Exhibit #1**) since 2006. *Rev. Cindy Falco –Di Corrado* works within the community feeding the homeless, worked with the Heart of Boynton Beach, (**See Exhibit #2 Certificate of Appreciation**) in ministering to those in need, counseling (**See Exhibit #3 Certificate of Completion**) and being available to anyone that is hurting. Diploma in Theology Life Christian University (**see Exhibit #4 Life Christian University**)

1. *Rev. Cindy Falco - Di Corrado* met *Linda Ortiz* and *Cristina Gomez*, which are mother and daughter, at a rally located in **Delray Beach on Atlantic Blvd.** and exchanged telephone numbers.
2. *Rev. Cindy Falco – Di Corrado* received a phone call from *Linda Ortiz* on May 29, 2020, and *Linda Ortiz* explained that both *Linda Ortiz* and *Cristina Gomez* were being arrested by Palm Beach County Sheriff's Office (hereinafter referred to as "PBSO") because *Linda Ortiz*, *Cristina Gomez*, and *Jose Gonzalez* entered the Sunshine Flea Market, 1941 South Military Trail, West Palm Beach, Florida 33415. (hereinafter referred to as "flea market") not wearing any facial covering and "PBSO" was dispatched to the "flea market" because of a disturbance.
3. *Rev. Cindy Falco – Di Corrado* arrived at the "flea market" to offer moral support and assistance to *Linda Ortiz* and *Cristina Gomez*.
4. This location is now known as West Palm Plaza, 4618 Forest Hill Blvd., West Palm Beach, Florida as per tax roll obtained from the Palm Beach County Property Appraisers Office and is assigned and identified as Parcel #00424412210000011) (**Exhibit #5 tax roll**) (hereinafter referred to as "plaza")

MAY 09 2021

5. On May 30, 2020, *Rev. Cindy Falco -Di Corrado* traveled solo in a 2007 White Hyundai Sante Fe (License Tag #KSFR80) to the corner of Military Trail and Forest Hill at approximately 1:00 p.m., to assemble peacefully and petition to redress, on the public sidewalk just outside the entrance to the "plaza". *Rev. Cindy Falco-Di Corrado* met *Linda Ortiz, Cristina Gomez, Manuel Severano, Jr., Gladys Severano, Jose Gonzalez* (now deceased), with domicile at 800 Ridgewood Drive, West Palm Beach, Florida, *Jadan Sanchez* 937 Green Street, West Palm Beach Florida 33405, and *Nick Fotopoulous*, with domicile at 2425 Presidential Way, West Palm Beach, Florida.

6. As they were exercising the 1st Amendment, the Florida Constitution, and Article 1, Section 4 of the Bill of Rights, "which states," The right of the people to be secure in their persons, houses, papers, and seizures, shall not be violated, and no Warrants shall issue, but upon probable cause, supported by Oath or affirmation and particularly describing the place to be searched, and the persons or things to be seized.

7. Within approximately 10-15 minutes a man dressed in a dark uniform, later identified as *Lt. Anthony Johnson* and two men dressed in green cargo pants, long sleeve shirts, black leather gloves, and black head and face covering approaches the assembly. The assembly is surprised to see the 3 men arrive, as they have done nothing wrong, and continue peacefully protesting. (Exhibit #6 - 14th Amendment)

8. None of these three men introduced themselves, nor gave an explanation of why they were there, or even who may have asked them to come to the plaza, the man dressed in the dark green outfit, is now known to me as *Lt. Anthony Johnson*, employed by the Palm Beach County Sheriff's Office, Watch Commander Division, he comes onto the scene. At no point during this incident do the other two people identify themselves.

9. *Lt. Johnson* of the PBSO, (hereinafter referred to as "*Johnson*"): walks over to the peaceful assembly on the sidewalk and says, "You are on private property".

10. *Rev. Cindy Falco - Di Corrado*: replies, "No, we are not. We are on public property." *Rev. Cindy Falco - Di Corrado* continues walking on the sidewalk chanting, waving her cardboard sign that has the word FREEDOM, and a small American Flag in her hand. (See Video #7 Blue Flash Drive, Exhibit # 5 plaza (tax roll) and #24 West Palm Plaza Pictures)

11. Johnson is then seen with a device held to his face. Johnson then walks down to the sidewalk area *where Rev. Cindy Falco-Di Corrado, Linda, Cristina, Manuel, Gladys, Jose, Jadan and Nick are peacefully assembling* and states: "Alright, here's the deal." (See Exhibit 7 Video Blue Flash Drive)

12. *Linda Ortiz*: replies: "Ok sir."

13. *Johnson* states: "You guys were warned yesterday, unfortunately you came on the property after being trespassed, which means you are subject to arrest". *Rev. Cindy Falco Di Corrado* was not trespassed the day prior.

14. *Cristina Gomez*: "You are going to arrest me again?"

15. *Johnson*: "yes ma'am." *Johnson* is speaking to those assembled and steps off the sidewalk and onto the road. The 2 men in green completely covered from head to toe are seen slowly moving around *Johnson*, you can see several marked police units pulling into the plaza and blocking the road, so as to corral them like a herd of cattle. (Exhibit #7 Blue Flash Drive and Exhibit #8 Orange Flash Drive Video)

16. More deputies arrive on the sidewalk area. *Johnson* gives what looks like a nod. *Rev. Cindy Falco Di Corrado* turns around and observes several officers coming towards her as if they were going to attack *Rev. Cindy Falco - Di Corrado*, who instinctively turns to protect herself. *Rev. Cindy Falco - Di Corrado* is now extremely in fear of her safety, security and health.

17. *Johnson, Casteel*, a woman officer, and an *unknown male officer*, all of which have both apprehended *Rev. Cindy Falco-Di Corrado* with their hands and were jerking her as to cause more fear for her safety, security and health. *Johnson* put *Rev. Cindy Falco - Di Corrado* in a choke hold, causing *Rev. Cindy Falco - Di Corrado* to gasp for oxygen. *Johnson* then used blunt force in a karate chop on *Rev. Cindy Falco -Di Corrado's* neck with his hand then you see *Casteel* who kicks *Rev. Cindy Falco - Di Corrado* in the leg. *Johnson, Casteel*, and unknown uniform male continue to maltreat *Rev. Cindy Falco - Di Corrado*, a 61-year-old American woman. (Exhibit #7 Video Blue Flash Drive, #8 Video Orange Flash Drive and #9 picture of karate chop on neck and BLM on I-95)

18. *Johnson* continued the assault and caused emotional trauma to *Rev. Cindy Falco - Di Corrado*. *Rev. Cindy Falco - Di Corrado* asked that her cell phone and keys be given to *Jose Gonzalez*. Instead, *Johnson* took *Rev. Cindy Falco - Di Corrado's* cell phone without her consent from her hand and threw it on the ground violently. Officer *Casteel* also grabbed the American Flag and *Rev. Cindy Falco-Di Corrado* signs and threw them on the ground. (Exhibit video #7 Blue Flash Drive and #8 video Orange Flash Drive)

19. Several men in green uniforms formed a circle around *Johnson, Casteel, unknown Deputy and Rev. Cindy Falco - Di Corrado*. (**Exhibit video #7 Blue and Exhibit video #8**)
20. *Johnson* continued to brutalize *Rev. Cindy Falco - Di Corrado*, without consent putting his knee in the middle of her back to cause her to drop on her knees. He twisted her arm in an upward motion toward the middle of her back to pry the key ring from her finger. (**See Exhibit #10 picture of Key Ring**) This caused *Rev. Cindy Falco - Di Corrado's* even more anxiety, fear of her safety, pain, and suffering, as it held all the keys to her property's. *Rev. Cindy Falco - Di Corrado* experienced excruciating pain inflicted by *Johnson, Casteel*, and an *unknown deputy* which caused *Rev. Cindy Falco - Di Corrado* to let out a loud scream as a result of the pain and agony being inflicted upon her. (**Exhibit Video#8 Orange Flash Drive**)
21. *Rev. Cindy Falco - Di Corrado*, was on a sidewalk which is public property, peacefully protesting when she was battered and beaten instead of being protected by the PBSO. (**See Exhibit #5 tax roll highlighted in orange and #7 Video Blue Flash Drive**)
22. *Rev. Cindy Falco - Di Corrado* was handcuffed while her arm was twisted up into the middle of her back and taken by *Casteel* to *Casteel's* sheriff vehicle. (**see Video Exhibit #7 Blue Flash Drive**). As *Rev. Cindy Falco - Di Corrado* was being taken by *Casteel*, *Rev. Cindy Falco - Di Corrado* asked if another officer could take her as she felt her safety was at risk. *Rev. Cindy Falco - Di Corrado* noticed approximately 14 or more people, some in green uniforms and some in green cargo pants long sleeve shirts and full facial masks, which greatly added to the fear for *Rev. Cindy Falco - Di Corrado's* security, safety, health and wellbeing. *Rev. Cindy Falco - Di Corrado* also notice approximately 8 vehicles blocking the entrance to the plaza. At no time did any Law Enforcement Officer state the Miranda warning to *Rev. Cindy Falco - Di Corrado*.
23. *Johnson* stated to the rest of the assembly they could leave freely if they left within the next 5 minutes in which they did.
24. At approximately 3:00 pm without *Rev. Cindy Falco - Di Corrado's* consent *Casteel* kidnapped her and shoved *Rev. Cindy Falco - Di Corrado* into the backseat of *Casteel's* sheriff's vehicle with the windows rolled up and no air conditioning. *Rev. Cindy Falco - Di Corrado* felt as though she was suffocating as it was stifling hot, and the vehicle was deprived of oxygen. *Rev. Cindy Falco - Di Corrado* could not help thinking "dogs are treated more humanely". As *Rev. Cindy Falco - Di Corrado* was being starved of oxygen, *Rev. Cindy Falco - Di Corrado* feared for her health, safety and security which caused her to cry out for help to an older unidentified officer near *Casteel's* sheriff's vehicle. *Rev. Cindy Falco - Di Corrado* kept asking him to please open the window so *Rev. Cindy Falco - Di Corrado* could breathe and complained of being in agony, the *unidentified officer* opened the door a little so *Rev. Cindy Falco - Di Corrado* could get some air.

25. The *unidentified officer* also asked *Rev. Cindy Falco - Di Corrado* if she needed to see a doctor as *Rev. Cindy Falco - Di Corrado* complained of the excruciating pain she was in due to the vicious attacks by *Lt. Johnson, Casteel and unknown officer*. *Rev. Cindy Falco - Di Corrado* was concerned about her arm, wrists, and her shoulder/neck area. *Rev. Cindy Falco - Di Corrado* said yes. The *unidentified officer* took *Rev. Cindy Falco - Di Corrado* out of the vehicle to take pictures of her inflammation, swelling, and the beginning of bruising on both the left and right wrist area and was able to breathe. (Exhibit #25 Picture of Wrists)

26. Sometime later, which seemed to be 30 to 45 minutes later, *Casteel* returned to the sheriff's vehicle and the *unidentified officer* said to *Casteel* words to the effect that *Rev. Cindy Falco - Di Corrado* was hurt and is in excruciating pain and to take her to the Hospital/Emergency Care Center to get checked out.

27. *Casteel* gets into the driver's seat of the marked sheriff's vehicle, then turned on the air conditioning, and began driving a short distance to a nearby gas station. *Casteel* and *Rev. Cindy Falco - Di Corrado* are talking to each other about the pain *Rev. Cindy Falco - Di Corrado* reported to the unknown male deputy prior to *Casteel* driving away from the plaza. *Casteel* asked *Rev. Cindy Falco - Di Corrado* if she moved the handcuffs from *Rev. Cindy Falco - Di Corrado's* back to the front of her it might be less painful. *Casteel* took *Rev. Cindy Falco - Di Corrado* out of the car and then changed the position of the handcuffs to the front of *Rev. Cindy Falco - Di Corrado*. *Rev. Cindy Falco - Di Corrado* did agree she felt less pain while sitting at the gas station.

28. *Casteel* at some point asked *Rev. Cindy Falco - Di Corrado* if she still wanted to be seen by the doctor and *Casteel* added words to the effect, "If I take you to be seen by the doctor, it is going to make the booking process take longer." *Rev. Cindy Falco - Di Corrado* responded, "I will let you know how I am feeling." It should be known *Casteel* and *Rev. Cindy Falco - Di Corrado* are still parked at the gas station in front of the gas pump, as *Casteel* needed gas in her vehicle. It is also realized at this time by *Rev. Cindy Falco - Di Corrado*, parked behind *Casteel's* sheriff's vehicle is *Orsino's* sheriff's vehicle and *Linda Ortiz* and *Cristina Gomez* are occupants in *Orsino's* vehicle.

29. While at the gas station *Casteel* began writing a police report. *Orsino*, also present in a sheriff's vehicle engages *Casteel* in conversation regarding the contents and the manner in which *Casteel* is writing the police report. *Rev. Cindy Falco - Di Corrado* witnesses *Orsino* appearing to be agitated and corrects *Casteel* to refresh her recollection as to the events and how they transpired. *Rev. Cindy Falco - Di Corrado* also witnesses *Casteel* disagree with *Orsino's* conversation and/or direction as to how the

report should be written, and *Rev. Cindy Falco - Di Corrado* witnesses *Casteel* tell *Orsino* words to the effect, "if you do not like the way I am writing the report then you should do it yourself". (See Exhibit #11 (A) Probable Cause Affidavit/ Police Report)

30. Now exiting the gas station after what feels like another 30 minutes or so, *Casteel* begins to travel to the Detention Center, at some point prior to arriving at the detention center *Casteel* asks *Rev. Cindy Falco - Di Corrado* how she is doing. *Rev. Cindy Falco - Di Corrado* responds to *Casteel*, "I am not hurting as bad." And *Casteel* proceeded to the detention center.

31. At the Detention center: 3228 Gun Club Road, WPB, *Rev. Cindy Falco - Di Corrado* was placed in a chair and waited her turn for to be processed. According to the time indicated on the PBSO booking website, the detention officers began processing *Rev. Cindy Falco - Di Corrado* at 3:49pm. An unknown intake officer pats *Rev. Cindy Falco - Di Corrado* down without her consent and *Rev. Cindy Falco - Di Corrado* was allowed to keep her own personal clothing on during this process. After the pat down the detention officers remove the handcuffs from *Rev. Cindy Falco - Di Corrado's* wrists, and she is then taken to have her picture taken; again, without her consent. *Rev. Cindy Falco - Di Corrado* is then placed into holding cell #9, later taken again without her consent to be fingerprinted. ((See Exhibit #11 (B) - booking paper)

32. On May 30, 2020 *Rev. Cindy Falco - Di Corrado* went through the exiting the jail process located at 3228 Gun Club Road, WPB, *Rev. Cindy Falco - Di Corrado* received two papers; one paper receipt for personal property and yellow arraignment paper (Exhibit #12 (A) and (B) Receipt for Personal Property and Arraignment paper) and is then released at 6:57 pm, as indicated on the PBSO booking website. (Exhibit #11 (B) booking paper)

33. It should be known, on May 30, 2020 that at no time during this entire event, was there any introductions, reason, or explanation given by any members employed by the Palm Beach County Sheriff's Office as to why or who gave direction to detain, inflict excessive and unnecessary force on *Rev. Cindy Falco - Di Corrado*.

34. On May 30, 2020, at 2:40 p.m Details on Wheels towed the 2007 Hyundai Santa Fe vehicle registered to *Luciano Di Corrado* location: 7641 Hooper Road, WPB, FL 33416. due to it being the weekend and Details on Wheels was closed Sunday he had to retrieve the car on Monday, June 1, 2020. *Luciano Di Corrado*, owner of the vehicle had to leave work from Boca Raton, Florida to retrieve his vehicle as *Rev. Cindy Falco - Di Corrado's* name was not on the registration. It was approximately a 3-hour process which cost \$223.00 to the towing company and the storage plus time from *Luciano Di Corrado* work at \$25.00 per hour. (Exhibit # 13 receipt Details on Wheels)

35. 06-01-2020, due to severe trauma, continual pain, suffering and concern about possible fractures in her wrists, arm, and upper body caused by *Lt. Johnson, Casteel and the unknown officer, Rev. Cindy Falco - Di Corrado* went to the Urgent Care of Palm Beach located at 5818 S. Dixie Hwy. West Palm Beach, Fl. 33405. Phone Number 561-479-4774. Walk in Clinic. Fee \$99.00 and \$180.00 for Ex-Ray. Total bill \$279.00
(Exhibit #14 receipt, #15 Results X-Ray from Teleradiology)

36. On 06-09-2020 due to continual pain and suffering from the brutal attack, choke hold and karate chop of *Lt. Johnson, Rev. Cindy Falco - Di Corrado* tried to find some relief for the excruciating pain. *Rev. Cindy Falco-Di Corrado* went to get a massage which was recommended by a friend at Toko Foot Spa located at 10833 Jog Road suite 184, Boynton Beach, Fl. 33437 Phone: 561-740-7744 and the cost \$40.00 (Exhibit #14 Receipt)

37. 06-12-2020 the pain continued in which was inflicted upon *Rev. Cindy Falco -Di Corrado's* body by *Lt. Johnson. Rev. Cindy Falco -Di Corrado* went to see Dr. Silverberg a Chiropractor located at: 1761 W. Hillsboro Blvd. Deerfield Beach, Florida 33422. Upon checking Dr. Silverberg stated there was damage. This created more concern for her safety, and health. Dr. Silverberg stated there is some damage and prescribed for *Rev. Cindy Falco - Di Corrado* to have an MRI. Cost \$90.00 for prescription for MRI and \$95.00 for a treatment at Dr. Silverberg's office (Exhibit #14 Visit to Chiropractor and #16 MRI Prescription for Windsor Imaging)

38. 06-15-2020 *Rev. Cindy Falco - Di Corrado* went to the Windsor Imaging Office located at 14590 S. Military Trail, Suite E12 Delray Beach, Fl 33484 due to being a senior American and concerned about her safety, security, and health. Their findings were some issues due to the abuse of *Lt. Johnson*. Cost \$300.00 with written report of the MRI.
(Exhibit #17 receipt and #18 Results of MRI from Windsor Imaging)

39. May 31 an article came out in the Palm Beach Post in regard to BLACK LIVES MATTERS (BLM) shutting down I-95 Hwy (not a public property) with no arrests nor citations issued. (Exhibit #19 Article in the Post Newspaper with attached Picture of BLM on I-95)

Cindy Falco-Di Corrado* emailed a complaint to Internal affairs to the *Palm Beach County State Attorney Dave Aronberg's* office in regard to the brutal and unconstitutional acts against her. Many of *Rev. Cindy Falco - Di Corrado* peers e-mailed letters and called *State Attorney Dave Aronberg's* office of the injustice that was done by the PBSO. 42. On February 23, 2021 during a zoom court appearance *Rev. Cindy Falco - Di Corrado* As one of we the people in Sui Juris.

43. It was made known to *Rev. Cindy Falco - Di Corrado* that both cases #50-2020-MM-004494-XXX-MB and #50-2021-MM- 00372-AXXX-SB were going to be held at the same date and time on April 1, 2021 at 9:30 AM. In court room: 9F (Main Branch) located at 205 N. Dixie Highway, West Palm Beach, FL 33401. 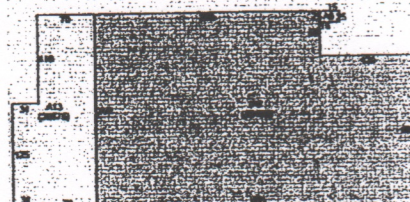

• Equal Protection – The 14th Amendment to the Constitution provides that "no state shall deny to any person within its jurisdiction the equal protection of the laws." Consequently, state governments and their agencies are prohibited from discriminating against any individual on the basis of classifications such as race, sex, or religion.

The Bill of Rights guarantees that government cannot infringe, nor continue to infringe upon the rights of the American people and is designed to ensure that the power of the government and its branches are kept in check. Its constitutional amendments specifically guarantee the rights of the people and set clear limitations of governmental power that have been perverted, misinterpreted, and obscured.

It forbids the federal government from violating any of the unalienable rights of the people and reserves all other rights that are not delegated to the United States, for the states. The state's authority and sovereign rights are determined by the people and all rights not delegated to the Federal or State governments by the people remains with the people.

The U.S. Constitution, as the Law of the Land, established by the people, for the people, and of the people, to define and enforce the laws common to the American inhabitants needed to form and maintain a functional government, protects and upholds the fundamental rights of the American people. The government as well as all those contracted by them are contractually bound by the terms therein to act in accordance with the U.S. Constitution to protect and defend the laws within that work to this end.

The UNITED STATES government, the state governments, all of their agencies, and subdivisions such as the city, county, boroughs, townships and banks are registered as corporations.

According to California Commercial Code 9307, "The UNITED STATES is located in the District of Columbia." The laws they pass only apply to the federal corporate venues identified by zip code or in the 100 sq. mile DISTRICT OF COLUMBIA.

UNITED STATES Government Corporation was created February 21, 1871 by the Forty-First Congress, Section 34, Session III, chapters 61 and 62, "An Act To Provide A Government for the District of Columbia." This is also known as the "Act of 1871."

This is reflected in U.S. Code, Title 28 – JUDICIARY AND JUDICIAL PROCEDURE, (Chapter 176) Section 3002 (15) (a, b, & c); which states that:

(15) "United States" means – (A) a Federal corporation; (B) an agency, department, commission, board, or other entity of the United States; (C) an instrumentality of the United States.

Corpus Juris Secundum, the second body of law, states: "The United States Government is a foreign corporation with respect to a state." Volume 20: Corpus Juris Secundum, (P 1785: NY re: Merriam 36 N.E. 505 1441 S.Ct. 1973, 41 L. Ed. 287)"

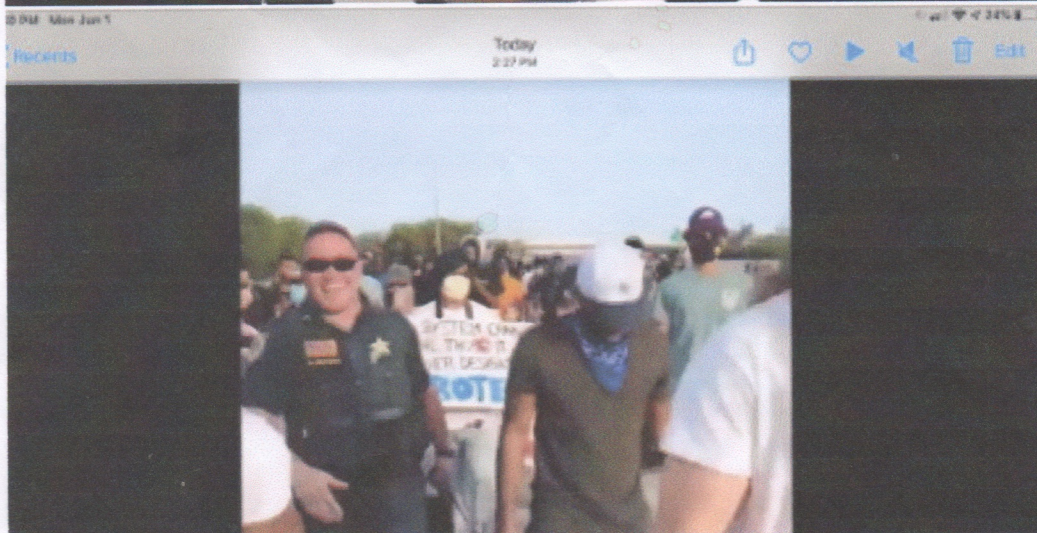
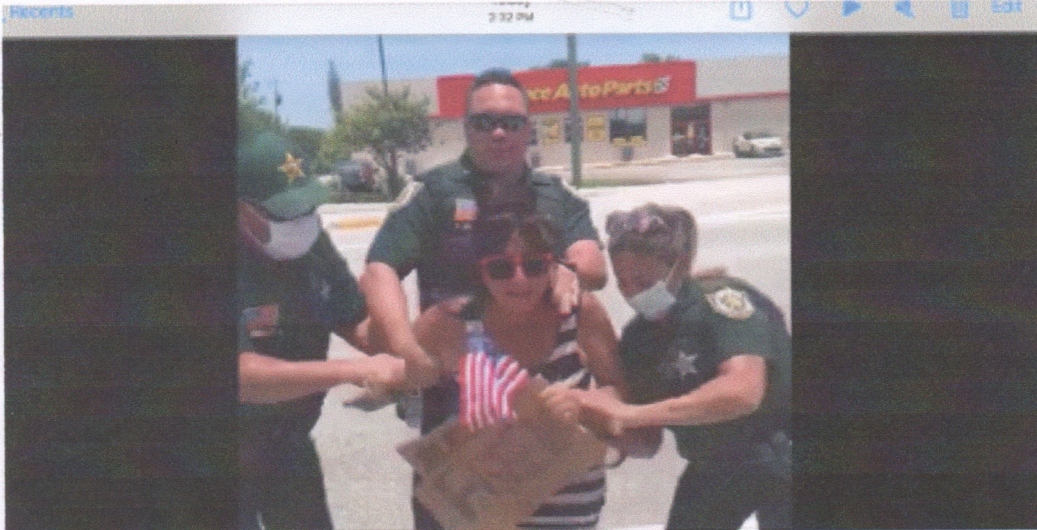

On the above date and time I responded to 1941 S Military Trail in reference to a disturbance.

Prior to arrival dispatch advised that security officers stated that two females who were arrested from the day prior were currently on the property again.

Upon arrival I observed three females who were previously trespassed from the property the day prior, standing in front of La Granja on the grass area. The three females identified as Cindy Dicorrado, Linda Ortiz, and Christina Gomez were observed by security officers in the parking lot five minutes prior to deputies arrival. The three females parked Cindy's 2007 Hyundai Santa Fe bearing FL tag# KSFR80 in the parking lot just west of La Granja, then walked east and through the property.

I made contact with the three females and spoke to Cindy initially who stated she was aware that she was trespassed from the property the day prior and would remove her vehicle. Cindy advised she was there because her friends, Linda and Christina were arrested the day prior and wanted to hold signs to the public. Cindy was advised that she was under arrest as she was trespassed from the property on 05/29/2020. Upon making contact with Cindy's left wrist, she began to pull away and immediately ran east into oncoming traffic. Lt. Johnson made contact with Cindy and immediately brought her to safety on the sidewalk. Cindy was then directed to the ground, handcuffed to the rear, checked for property fit and tightness and placed in my patrol vehicle.

Deputies attempted to make contact with Linda and Christina at which time the two fled in a green van (bearing FL tag #NMDH46) driving westbound on Forest Hill Blvd. Deputies conducted a traffic stop where Linda and Christina were both identified by D/S Orsino #28991. It should be noted D/S Orsino was an arresting deputy from 05/29/2020. Linda and Christina were handcuffed to the rear and placed in the patrol vehicle.

Cindy later complained of wrist and shoulder pain and was transported to a walk in clinic for medical clearance.

All parties were later transported to the County Jail for Proper Booking.

WPTV-Channel 5 reported that people tried to break into the Target store across the street from the Outlets mall on Palm Beach Lakes Boulevard as well.

There also was police presence at the Gardens Mall late Sunday but there didn't appear to be any protesters around. A helicopter was seen circling the mall.

UPDATE 9:30 p.m.: The crowd is now apparently headed to the Palm Beach County courthouse in West Palm Beach.

George Hollins of West Palm Beach said he led efforts to disperse the crowd on Palm Beach after meeting officers in riot gear on Ocean Avenue north of Mar-a-Lago: "They say we free, you see what's going on, we don't have a voice."

The town sent an alert at 9:50 p.m. saying that the Southern Avenue Bridge will be closed east and west for the remainder of the night. That's the bridge that leads to President Donald Trump's Mar-a-Lago estate.

Mar-a-Lago has had increased security in recent days following sometimes violent protests outside the White House. Trump is not at Mar-a-Lago and it's not believed that any of his relatives are there.

UPDATE 9:15 p.m.: West Palm Beach Mayor Keith James issued a curfew beginning at 9 p.m. and lasting until 6 a.m. after protesters descended on Clematis Street and had tense moments with police in riot gear.

Meanwhile, things are also heating up on Palm Beach, home to President Donald Trump's Mar-a-lago estate. Protesters marched to the island earlier and now are facing law enforcement in riot gear who are urging them to return home. Over loudspeakers from PBSO cars can be heard: "Turn around now." There are more than a dozen deputies in riot gear.

"Don't give them the power ... let's go," one protester said. "Let's save our lives so we can live to fight another day."

The town has a curfew from midnight to 6 a.m.



Over the bridge in West Palm Beach, the mayor's release stated the curfew is for the next 72 hours and "people are asked to peacefully disburse from any street in the City ..." It also says during the curfew people can still travel to work.


"The public's safety is my top priority," the statement from the mayor states, "especially during this time of great unrest in cities nationwide. The nighttime curfew is an additional tool to promote public safety in our city."

 **UPDATE 8:25 p.m.:** Interstate 95 has officially reopened after demonstrators earlier had blocked traffic. 

Also, a group of protesters are gathered on Clematis Street in downtown West Palm Beach in a tense standoff with police. West Palm beach police in riot gear sprayed some of the crowd with pepper spray earlier but things are at a standstill now.

It's not clear if the protesters were part of an earlier march that started at Rosemary Square and eventually blocked traffic on I-95.

Also, apparently now some of the protesters are trying to head to Palm Beach, possibly to make a statement near President Donald Trump's Mar-a-Lago.

 Traffic is blocked on Ocean Avenue from Brazilian to Worth Avenue on the island.

Palm Beach County Sheriff's Office deputies and Palm Beach police are seen blocking Worth Avenue, the ritzy shopping street on the island.

Also, South Ocean Boulevard is shut down from Hammon Avenue to South County Road.

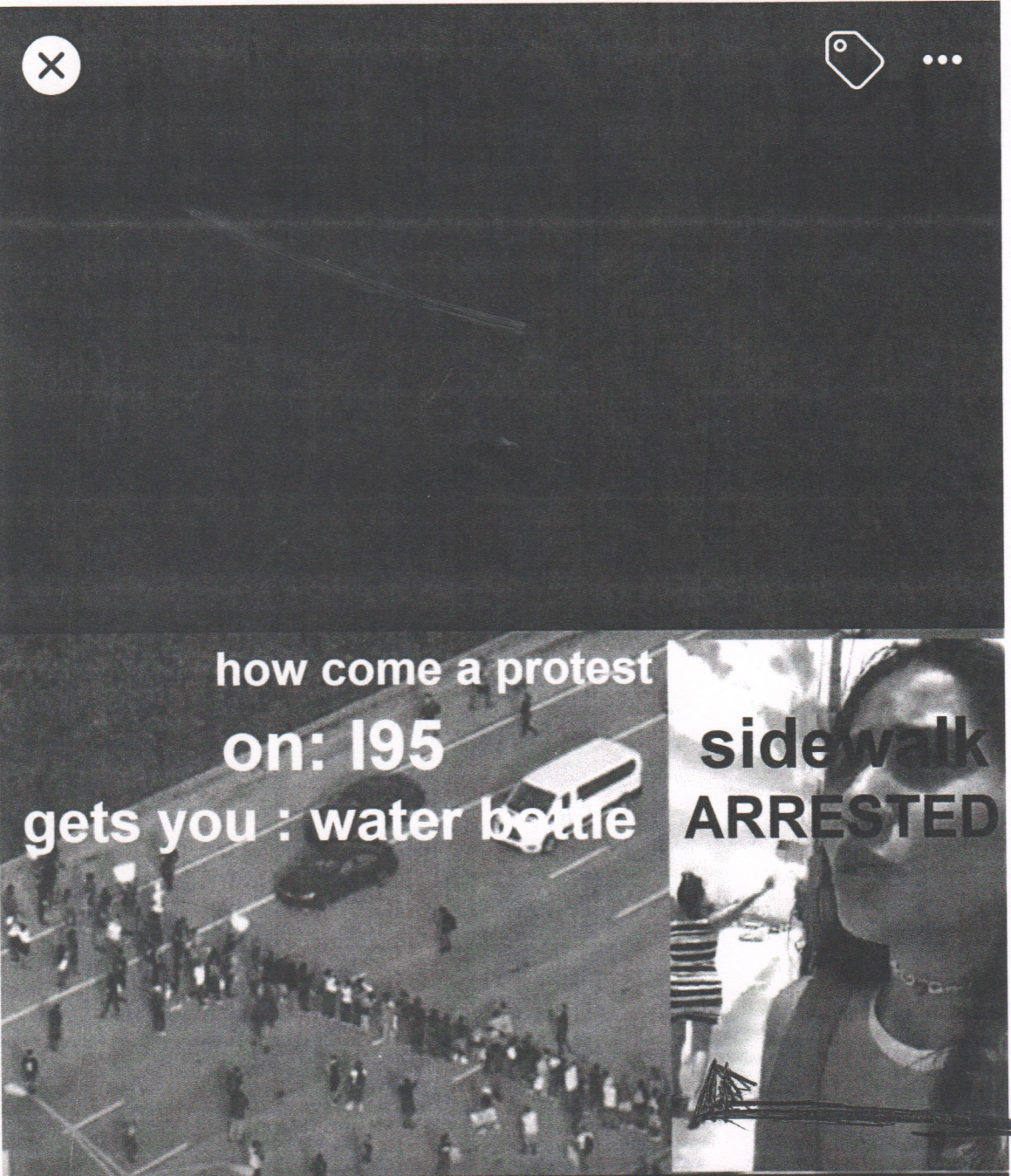

When they were asked to leave, they left," said Florida Highway Patrol Lt. Yanko Reyes. ~~No arrests were made or citations issued.~~

West Palm Beach Police have still closed traffic on Okeechobee Boulevard at Parker Avenue.

The Palm Beach Post caught up with some of the demonstrators, most of whom were young. They said they learned about the demonstration on Instagram. For many, it was their first experience at a march.

"What surprised me most was how many different people there were — black, white, Hispanic," said Alexia Law, 21, of West Palm Beach. "It was beautiful."

Law marched along I-95 with her father, David Law, who participated in demonstrations after the shooting of Rodney King, a black man who was violently beaten by Los Angeles police in 1991. Law said he learned about Sunday's event from his daughter.

"I loved it," said Law, adding that there was no violence. "I give it to the police for not flaming the fire."

Jeinmy Cruz, 20, of West Palm Beach said she was scared, after seeing demonstrations in other cities turn violent. She attended the event with several friends.

"It was powerful, there was a lot of love," Cruz said.

Jennie Campbell, a West Palm Beach 21-year-old, said she, too did not know what to expect.

"We were scared of what the police were going to do," Campbell said. "But they were raising their fists with us."

Gavin McClinton said the I-95 takeover sprung out of a protest he organized earlier in the afternoon at the county courthouse.

It was distinct from the one that started in Rosemary Square, he said, but the two eventually morphed and protesters later moved to the interstate.

"We've just had enough," said one protester on the highway, Clarence Alexis.

"We're fed up with the whole process."

Carrying a bullhorn, McClinton said he worked with PBSO to get protesters off the highway once they got their message across.

The 26-year-old Riviera Beach resident described it as a peaceful resolution to the day.

"Some of the richest people in the world live here right? But they don't understand what us everyday folk go through. ... We're tired of the police being able to get away with murder."

UPDATE 7 p.m.: The George Floyd protesters who marched earlier Sunday and eventually blocked lanes of Interstate 95 are moving off the highway. But many protesters remain and the highway is still closed.

UPDATE 6:30 p.m.: A peaceful protest at Rosemary Square on Sunday afternoon to bring awareness to the death of George Floyd by Minneapolis police turned into a march that eventually led to Interstate 95, blocking traffic south of Okeechobee Boulevard by Sunday evening.

"We're just trying to keep everybody away from the highway," said Florida Highway Patrol Lieutenant Yanko Reyes about 6:30 p.m.

He said troopers are mobilizing their "quick response team" with the Palm Beach County Sheriff's Office to begin moving protesters off the highway.

"Obviously we want to keep the flow of traffic on the highway," Reyes said.

He asked protesters to stay off the highway.

West Palm Beach police reported both northbound and southbound lanes of I-95 were affected, closing the highway from Palm Beach Lakes Boulevard to Southern Boulevard. They urged motorists to stay clear of the area.

West Palm Beach police vehicles with their lights on have shut down westbound Okeechobee Boulevard at the intersection of Parker Avenue and Okeechobee Boulevard.

The protest had started earlier at Rosemary Square.

EARLIER Sunday: Several hundred people of diverse races and ages and mostly young had gathered after an hour and a half march that took them through downtown West Palm Beach, from the Harriet Himmel Theater in Rosemary Square to the Palm Beach County Courthouse and the City of West Palm Beach Police Department.

Their chants and signs varied, but their message was unified - They were outraged by the Memorial Day death of Floyd, a black man who was held under the knee of a Minneapolis police officer until he died. And they wouldn't accept it happening again.

Tyesha Peterson stood in the grassy median in front of the Restoration Hardware store at Rosemary Square, holding a sign and watching several people kneeling solemnly and silently before her, fists raised in the air.

She asked why she was there.

"My skin," she said. "I'm black. I have black brothers, a black boyfriend and a black father. Are they next?"

"It's not the first black man they've killed," she said, gesturing to signs bearing the names of others killed by police including Louisville's Breonna Taylor and 12-year-old Tamir Rice of Cleveland. "So it's not my first protest."

"Say his name!" a leader chanted.

"GEORGE FLOYD!" the crowd answered.

News of Sunday's protest appeared online and by word of mouth at other protests, including Saturday's event in Lake Worth Beach. A social media post bearing the symbol of Black Lives Matter had been circulated, but no one at the protest Sunday seemed to know, or was willing to say, who the official organizer was.

"Nobody wants to know," said Rolando Barrero of the Hispanic Democrats of Palm Beach County, who brought about 15 people with him "keeping track" of the proceedings. He would not comment on violence at other protests nationwide and said he was focusing on Floyd's murder and the changes that need to be made.

"I support all four cops being indicted. I want the third degree murder charges against (former officer Derek Chauvin) to be aggravated first degree murder. It's an anathema. If it were you or me, with a knee to a man's neck in broad daylight, that would be the charge," he says.

As the march proceeded east, then south and eventually back north on Quadrille Boulevard, they attracted attention from motorists. While at least one woman tried to pick a fight in front of the Harriet Himmel Theater, leaning out of her pickup truck even as the light changed, no one took the bait.

"We'll pray for you," one protester said before the truck finally took off. Later, at the railroad tracks, a man paused to lean out of his car with an American flag.

"You BETTER protest that s***!" he said encouragingly.

Protesters insisted that they were there to focus on justice, and along the march, there appeared to be no issues. "We're keeping it peaceful," said Boynton Beach's Courtney James, who also attended Saturday's protest in Miami Beach. "Anyone who doesn't is not with us."

The aggression seen online and on television at other national protests on the part of police and crowds was on the mind of West Palm Beach comedian Fat Chops, who said he was reluctant to come until his teenage children talked him into it, "and I'm so proud of them."

There was some police presence, but not overwhelming, with officers directing traffic. As the group paused in front of West Palm Beach Police headquarters, Deputy Police Chief Rick Morris declared that his department "was here to help maintain the peace. We're here to support."

Also there "as a peacemaker" was former Riviera Beach mayor Bishop Thomas Masters, who said that he'd spent years as a protester but "I'm retiring. I love these young people. They're looking to leadership and if we aren't here, where are they gonna go?"

The young protesters like Tyesha Peterson said it was their duty to lead, for themselves and for others like them. Before her, protesters dropped to their knees for nine minutes, the estimated amount of time that Floyd was under Chauvin's knee.

For her part, she said she thought it was a positive day. "Everyone's coming together," she said. "This is change."

The Rights of Protesters in Florida

Under the First Amendment to the United States Constitution, every citizen in the country has a right to peacefully protest. But that does not mean that they can protest in whichever manner they choose, even if they remain peaceful while doing so. And recently, Florida tried to infringe upon those rights by passing a state law that could put the lives of protesters in danger. Laws Protestors Must Follow

Protesters are guaranteed the right to protest in a peaceful manner, but they cannot break any Florida laws while doing so. This includes outright acts of breaking the law such as uttering threats, trespassing, or theft but it also includes minor infractions such as holding up traffic when protesters block sidewalks or roadways.

In these instances, authorities may break up a protest but they can never prohibit a peaceful protest from taking place simply because they disagree with the content of the protest.

Even in the case of minor infractions, authorities can only ask the protesters to move or, in the case of noise violations, to keep the volume level down. Typically they cannot prevent a protest from happening when protesters comply with these requests.

Senate Bill 1096

While the rights of protesters are largely protected under the First Amendment, Florida lawmakers recently tried to pass a bill that would threaten the very lives of protesters. That bill, pushed by Senator George Gainer and Representative Jayer Williamson, would protect drivers who hit or ran over protesters that were obstructing traffic during a protest or demonstration.

Under the bill, drivers would essentially be protected if they hit protesters with their car and would not be held liable for injuries, damages, or even death. The bill was not passed and while Gainer has said he would no longer try to push the bill through, Williamson said it was something that was "still in consideration".

Florida is just one state that has tried to pass such a bill but the fact remains that it is simply unconstitutional. Protesters, whether they are in Florida or Washington, have the right to

It was a pleasure speaking with you yesterday. I appreciate your prompt response to the serious concerns regarding the arrests of Cindy Falco DiCorrado, Christina Gomez and Linda Ortiz. This email is CC'd to the appropriate regulatory agency as you suggested, for review of the officers involved.

The three women were arrested during a peaceful Facebook live demonstration on what is clearly public property. This is evident by the multiple angles the incident was photographed and videoed in correlation with the Palm Beach County Tax Map. Photos have surfaced (attached) of the same arresting officer, Lieutenant Johnson, recently walking gleefully with protesters who were in clear

violation of Florida Statutes **316.2045** blocking a public highway and **870.02, unlawful assembly**. In the interest of justice and avoidance of taxpayer waste which would inevitably be incurred for a trial that does not meet probable cause, I'm requesting the State abandon all criminal prosecution of the defendants in this matter.

I will be following up with internal affairs. The women have complaints of physical injury resulting from the arrests. I have a great deal of concern there should be an investigation into why this officer appears to favor one group of protesters over another. I have immense respect for our PBSO, my personal experiences with the department have been very positive. In light of the death of George Floyd and the injuries sustained by the women in the above mentioned arrests, I believe it is imperative we catch questionable behaviors early on to be sure videos and photos that surface on social media do not cast a bad light on our sheriff's department as a whole giving the image we as a County that condone police brutality. The women involved as well as eye witnesses will be sending emails to IA as well. I have confidence under your watch the matter will be justly resolved.

Dear Internal Affairs,

I write to you with a heavy heart. My Name Is Cindy Falco-Di Corrado aka Rev. Cindy Falco of Open Arms and Open Hearts Ministry . I was arrested on May 30th 2020.

Here is what transpired.

Myself and a few others were on Military Trail at the entrance to Sunshine Flea Market Shopping Plaza but NOT on their Property. (Please check tax roll)

We were there with our signs exercising our 1st Amendment Rights. Our signs read: Freedom, take off your masks and breathe, Liberate, etc.) We were Waving at people when Lt. Johnson came up to us and asked us what we were doing. As you can see in the video we were talking and sharing why we were there then all of a sudden about 14 or more police with their faces covered (look like a Militia) show up and 8 cars block the entrance and three deputies are coming towards me with a vengeance then Lt. Johnson says your under arrest and goes to grab my arm and reflex was to get away as it looked they were going to gang bang me. (I have been abused and attacked in my life and so that was my response because I knew we didn't do anything wrong) It was fearful site to see and more so to experience. WE did NOT do anything Wrong and this whole thing was a Lie. He then puts me in a choke hold and Almost chokes me to death as I could not breathe then he changed it to a karate chop and what felt like his knee in my back. He then twists my arm up my back and drops me to the ground. Deputy M. Casteel Badge # 28275 kicks me also in the video that you can see.

They proceed to tackle me as in video (you can see them in video) and they grab my phone out of my hand and throw it. I said please give my keys to my friend which was on my finger, so that he could move my car but the Lt. Johnson abusively was jerking my keys from my hand. He didn't give my keys to my friend which I found out when I was released from Jail and had to hunt to find out where the car was. I don't which police called and had my car towed to inconvenience me and cost me money as with the Covid situation and I do weddings Parties and events wasn't able to work and did not collect unemployment. The inhumanity of it all just breaks my heart that there are such cruel and inhumane officers to citizen of the Beautiful Country. Never in A million years did I ever think that the police would be the abusers (criminals) of the Law. My father was a Miami Dade Police officer and would be so shocked to of known how his daughter was treated. Late Officer Robert (Bob) D. Falco gave 25 years to the Force and to see what it looks like today just shameful.

They told me that I was going with Deputy M. Casteel. I didn't want to go in her car as I know that she called the false arrest and I was illegally without cause arrested. She also was the one who kicked me. I didn't know what abuse she would do to me and I specifically asked for another police officer to take me but they made me go with her. She left me in the car for appx 35 minutes in the heat in the car with all the windows rolled up as I saw about 7 Police officers then run to get Cristina and Linda. It is illegal to even leave a dog in the car with the windows rolled up. She did it on purpose to continue the police brutality that was put upon me a Senior Citizen, Wife, Mother, grandmother. This was unfathomable.

There was an older police officer I shared with him that I could not breathe and if I was his wife or mother would he want this for her. He opened the door a little bit so I could breathe.

My shoulder was hurting me because of the way they twisted my hand with the cuffs. My wrists were killing me due to the tightness of the cuffs again on purpose to hurt me. I told the Nice police officer that I was hurt and he waited till Deputy Castell finally came back and had me get out of the car and took pictures.

Then we sat longer and went to the Gas Station so Deputy could be gas in her vehicle with Cristine and Linda in the car behind me. She was writing up the reports as well and she knew she would have had to take me to the doctors so what she said : It will take longer if you go to the doctors and you won't get out till late if I put the cuffs to the front will that work for you. I said if my shoulder quits hurting then yes. So, she took me out of the car and released the pressure and put the cuffs in the front of me. What I didn't know her shift was over and so she really wanted to leave.

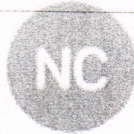

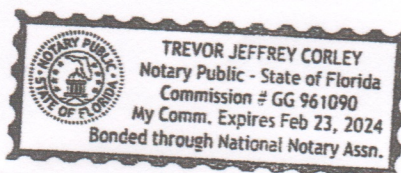



28.222 Clerk to be county recorder.—

- (1) The clerk of the circuit court shall be the recorder of all instruments that he or she may be required or authorized by law to record in the county where he or she is clerk.
- (2) The clerk of the circuit court shall record all instruments in one general series called "Official Records." He or she shall keep a register in which he or she shall enter at the time of filing the filing number of each instrument filed for record, the date and hour of filing, the kind of instrument, and the names of the parties to the instrument. The clerk shall maintain a general alphabetical index, direct and inverse, of all instruments filed for record. The register of Official Records must be available at each office where official records may be filed.
- (3) The clerk of the circuit court shall record the following kinds of instruments presented to him or her for recording, upon payment of the service charges prescribed by law:
 - (a) Deeds, leases, bills of sale, agreements, mortgages, notices or claims of lien, notices of levy, tax warrants, tax executions, and other instruments relating to the ownership, transfer, or encumbrance of or claims against real or personal property or any interest in it; extensions, assignments, releases, cancellations, or satisfactions of mortgages and liens; and powers of attorney relating to any of the instruments.
 - (b) Notices of lis pendens, including notices of an action pending in a United States court having jurisdiction in this state.
 - (c) Judgments, including certified copies of judgments, entered by any court of this state or by a United States court having jurisdiction in this state and assignments, releases, and satisfactions of the judgments.
 - (d) That portion of a certificate of discharge, separation, or service which indicates the character of discharge, separation, or service of any citizen of this state with respect to the military, air, or naval forces of the United States. Each certificate shall be recorded without cost to the veteran, but the clerk shall receive from the board of county commissioners or other governing body of the county the service charge prescribed by law for the recording.
 - (e) Notices of liens for taxes payable to the United States and other liens in favor of the United States, and certificates discharging, partially discharging, or releasing the liens, in accordance with the laws of the United States.
 - (f) Certified copies of petitions, with schedules omitted, commencing proceedings under the 1Bankruptcy Act of the United States, decrees of adjudication in the proceedings, and orders approving the bonds of trustees appointed in the proceedings.

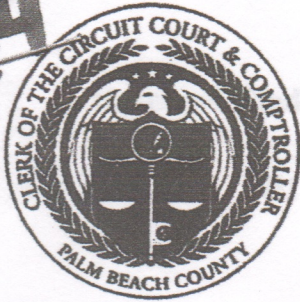

Dear Reverend Falco- Di Corrado,

Copies of the documents you presented to the Clerk of the Circuit Court & Comptroller's Office of Palm Beach County have been reviewed. A determination was made that the documents entitled *Affidavit* do not meet the statutory requirements outlined in the Florida Statutes for recordation.

The Clerk of the Circuit Court & Comptroller's authority to record documents is found in Florida Statute 28.222. Only those documents enumerated therein are eligible to be recorded. Florida's Attorney General has interpreted this statute numerous times and it is noted in Attorney General Opinion number 2005-17.

Pertinent sections are excerpted for your convenience:

Section 28.222, Florida Statutes, provides that the clerk of the court "shall be the recorder of all instruments that he or she may be required or authorized by law to record in the county here he or she is clerk." [2] (e.g.). The statute enumerates certain instruments that must be recorded and recognizes the clerk's responsibility to record, upon payment of the service charges prescribed by law, "any other instruments required or authorized by law to be recorded."

However, this office has also stated that the clerk of court may not accept for recording in the official records any document that the law does not authorize or require him or her to record. In Attorney General Opinion 90-69, this office considered whether the clerk of the court must record



documents not defined in section 28.222, Florida Statutes, such as living wills, child custody agreements between parties without court approval, foreign state birth certificates, foreign country birth certificates and documents in a foreign language without an English translation. The opinion focused on the limitation upon the authority of the clerk to perform only those duties authorized by law and recognized the statutory mandate that the clerk record "all instruments that he or she may be required or authorized by law to record in the county where he or she is clerk." Based on these considerations, this office concluded that the clerk is not authorized to record any document or instrument that is not specifically required or authorized to be recorded by section 28.222, Florida Statutes, or by any other provision of law.
