Club 45 is not charted by the Republican Party of Florida, aka RPOF which puts Joe Budd as an elected official who is a Republican State Committeeman in violation of his oath of office.

4. Elizabeth Felton domicile: 6598 Nova Lane, Lake Worth Fl., 33462 witnessed the event. (See Exhibit #3 Affidavit)
5. On April 26, 2021 Rev. Cindy Falco - Di Corrado, Luciano Di Corrado and Linda Ortiz went to get signatures for a candidate who is running for District #18 and to see General Flynn. Rev. Cindy Falco - Di Corrado, and Linda Ortiz were helping the Candidate set up her table which seemed to set off the following events which transpired. See Luciano Di Corrado, Linda Ortiz and Elizabeth Felton affidavits (Exhibits #1, # 2 & #3 Affidavits)
7. Rev. Cindy Falco - Di Corrado was standing on the sidewalk outside of the meeting room getting signatures for a Candidate which Joe Budd originally had given permission to do but due to the hostility of some of the Republican's (Republican in name only RINO's) they created a disturbance. Vincent Caldara came out of the Hilton Majesty Room with an unidentified Police Officer (now known as D/S A. Lopez, the taller one - as description given by Sgt. Tim Dailey #7333 of the PBSO). D/S Lopez said they were going to arrest Rev. Cindy Falco- Di Corrado for trespassing. Rev. Cindy Falco - Di Corrado asked by whose authority and how was she trespassing? Vincent Caldara said by Joe Budd's authority. Rev. Cindy Falco - Di Corrado said: "she did nothing wrong." and

D/S Lopez stated that they were going to re-trespass Rev. Cindy Falco-Di Corrado who was legally on the Airport Hilton Property as per 42 U.S.C. section 2000 (a) and 42 U.S. C. 2000 (3), 42 U.S.C. section 2000 (c) (Exhibit #4 42 U.S.C)

8. Rev. Cindy Falco -Di Corrado was trespassed a year ago for speaking the truth at one of Club 45 meetings and was accosted by Larry Snowden, Vincent Caldara and some motorcycle group. There wasn't any documentation, nor was there a ticket written. This was verbal to my knowledge as Rev. Cindy Falco -Di Corrado did not receive any documentation. Rev. Cindy Falco- Di Corrado honored the verbal statement anyway.

9. The year had passed and Rev. Cindy Falco - Di Corrado did not think twice about helping the Candidate to get signatures outside on the Airport Hilton's Property nor to go and see General Flynn who was the guest speaker in which she had tickets to the event for that evening. (Exhibit #5 tickets and #6 Copy of Trespass)

10. As, Rev. Cindy Falco - Di Corrado was getting signatures on the sidewalk in a public accommodation as per Florida Title 44 Section 760.02 states Public accommodations. D/S Lopez badge number 8211 (the tall one), Vincent Caldara and second unidentified police (now known as Deputy Spears (the short one) approaches Rev. Cindy Falco - Di Corrado to arrest her which puts them in violation of 42 US code 3617. (Exhibit #7 Code copy of US CODE)

11. Rev. Cindy Falco -Di Corrado says to D/S Lopez that she could not recognize him until she saw his certificate of Registration as a Peace officer and required his supervisor to be present at all times and asked if the state registers and records the people? D/S Lopez pulls his tags from under his vest and flashes it at Rev. Cindy Falco- Di Corrado. Rev. Cindy Falco -Di Corrado said: that is not your certificate of registration as a peace officer. D/S Lopez changed his attitude a little bit upon hearing Rev. Cindy Falco-Di Corrado statement to him which Deputy Spears (the shorter one as per Sgt. Daily #7333) heard and did not comply also but states: I will arrest her; I will do it for you.

12. Rev. Cindy Falco Di Corrado had paid tickets to go inside Club 45 in the Majesty room but did not go into the room. D/S Lopez was surprised to hear that Rev. Cindy Falco - Di Corrado had tickets and seemed confused about the whole scenario. Vincent Caldara said he did not care that Rev. Cindy Falco - Di Corrado had tickets for the event, nor did they offer to pay her back for the three tickets.

13. D/S Lopez continued to walk on with Rev. Cindy Falco - Di Corrado, Luciano Di

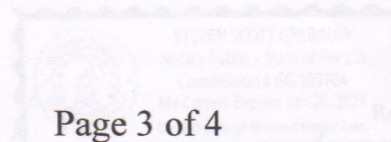

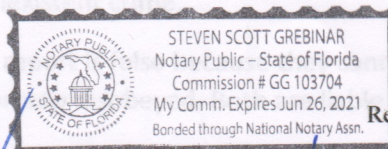

On April 26, 2021 at approximately 6: 00 p.m. My wife Rev. Cindy Falco -Di Corrado who is an elected precinct committeewoman for the Republican party, Linda Ortiz and I went to the Airport Hilton in Palm Beach to help a candidate to promote her and get signatures and to listen to General Flynn.

I saw a sheriff come to my wife, Rev. Cindy Falco – Di Corrado and he pulled her aside away from the crowd and he said she could not go inside. (she never stepped foot inside) He said that she had a warning for one year for trespassing which she responded the expiration was no longer valid as it was past the one-year warning.

Then she said to the sheriff she could not recognize him until she saw his certificate of registration as a Peace officer and required his supervisor to be present. He then pulled out his ID and flashed it at her.

He wanted to use his power of authority over her then when he was talking Vinny came over and said re-trespass her (my wife did nothing wrong) and was on the sidewalk. My wife Rev. Cindy Falco – Di Corrado asked by whose authority and he said Joe Budd the State Committeeman for the Republican party. The other sheriff said Rev. Cindy Falco – Di Corrado should be arrested. (again, my wife did nothing wrong)

My wife asked why can't I go inside as I have tickets. The sheriff was surprised and said show me the tickets. She showed the tickets, and he didn't do anything. The other sheriff kept saying I can arrest her for you and I felt very uncomfortable and felt the situation would escalate so I pulled my wife far away from the Sheriff and went closer to the car and we left.

My wife did not do anything wrong and was explaining the situation as the prior trespass was null and void. It expired on January 13, 2021 please see report #21-025857

Aurigemma v State, 801 So 2d 982 (2001)- give you the elements of false reporting of a nonexistent crime.

To be guilty of false reporting of nonexistent crime, one must willfully impart, convey, or cause to be imparted or conveyed to a law enforcement officer false information or reports concerning the alleged commission of a crime, knowing such information or report is false, in that no such crime has actually been committed sec 817.49 Fla. Stat. (1997)

State Committeeman Joe Budd and Vincent Caldara are the ones who need to be charged as per Sec. 817.49 Fla. Stat (1997) for reporting a nonexistent crime.

Vincent Caldara and Joe Budd know their report is false because they cannot express the "valid" or Lawful order that Rev. Cindy Falco – Di Corrado disobeyed. Both are liable because they knew the report to the police was false.

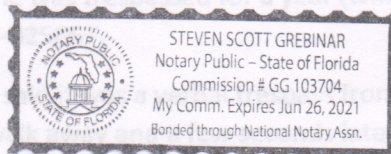

I Linda Ortiz domicile: 800 Ridgewood Drive, West Palm Beach witnessed two court house police officers names are now known to me now as Deputy A. Lopez Badge #8211 (the Tall one) and D/S Spears ID number 6897 (The short one as per Sergeant Tim Daily #7333 court house) and Vincent Caldara domicile: 4603 N.W. 44th Street , Tamarac, Fl. Phone number: 305-251-8000 .

I received a phone call from Rev. Cindy Falco – Di Corrado on April 24, 2021 regarding helping a Candidate get signatures. On April 26, 2021 I went with Rev. Cindy Falco – Di Corrado and her husband Luciano Di Corrado to go to the Airport Hilton to help the Candidate who is running in district #18 for Congress. As we arrive, I observed two ladies and I do not know them by name, but I know them by face and when they saw Rev. Cindy Falco- Di Corrado and I, one of the ladies was breaking her neck to see if it was Rev. Cindy Falco – Di Corrado and I, and more so for Rev. Cindy Falco-Di Corrado. I had seen them approach another lady holding a sign and observed them saying something then they went inside the building.

As we were helping the Candidate set up her table at the Club 45 , Airport Hilton, WPB, Rev. Cindy Falco – Di Corrado was getting signatures and I was helping set up the table I observed another lady with a name tag that I could barely see and asked: "who gave you permission to be set up out here". At that point Liz, the manager of the Candidate said: Joe Budd gave us permission to set up here. Then the lady went inside and brought another lady and said she spoke to Joe Budd and he said he didn't recall saying they could be out there to Liz, candidate manager. Liz stated: that was not right as Joe Budd said that they could set up.

Another person who was also helping, his name was Dan putting water and ice down who was going to hand them out for free. The same lady with the name badge was accusing him of selling water to the people, which he had just put the bottles on the ground and did not even open the pack of water we were just setting up.

When they saw Rev. Cindy Falco-Di Corrado and I setting up to help the candidate, that's when things turned. I saw the tall officer and Vinny approach Rev. Cindy Falco – Di Corrado and the Tall Officer was talking to her and so I came closer to see what was happening. I was hearing the officer talking to Rev. Cindy Falco-Di Corrado that she was trespassed for a year (which was on January 13, 2020 as looked it up later) please see PBSO #20-025857.

Rev. Cindy Falco – Di Corrado said it was a verbal trespass from their club 45 for a year which Cindy said was completed. I saw Vinny walk away and a few seconds later short police came.

I hear Rev. Cindy Falco- Di Corrado telling the tall officer something to the effect of she needed to see a paper of him being a peace officer, he flashed his ID. The short police then said I'll do it! I'll will do it (alluding to he would arrest her). Rev. Cindy Falco- Di Corrado asked if she was being re-trespassed and Vinny said yes and Cindy asked by whom and he said: Joe Budd the State Committeeman for the Republican Party which Rev. Cindy Falco – DI Corrado is also a precinct State Committeewoman.

Cindy her husband Luciano and I continued to walk to the car with no incident.

On Monday April 26th I arrived at The Palm Beach Hilton Air Port with marketing materials for a candidate. We intended to hand out flyers/business cards and gather signatures. I had asked Joe Budd if that was ok and he said it was.

We arrived with approximately 8 volunteers. Among them were Tom Vaughn and Cindy Falco DiCorrado. Cindy was helping the candidate set up a table. As I arrived I was informed we were to take down the table and could only hand out materials. We took down the table and display. I was informed by security that the club did not want Cindy or Tom on the premises due to a previous fallout between the individuals and club board members. Since I was the one who invited the volunteers I asked both to leave. Tom did and Cindy informed me she had been trespassed over a year ago and it was no longer valid. She also informed me she was holding tickets for the event the club was holding. At that point I walked away from Cindy and the officer since the purchased tickets had nothing to do with me. After speaking with the officer Cindy left. To my knowledge Cindy never entered the building.

I apologized to Joe and security and asked if there were any other volunteers the club did not want there and was told "no." WE hold REC meetings at the same hotel. Cindy is a precinct representative and is concerned she will not be able to fulfill her requirement to attend meetings. I believe she is looking for clarification as to whether she is trespassed by the hotel or just the meeting room when rented by club 45.

- Notes

(a) EQUAL ACCESS

All persons shall be entitled to the full and equal enjoyment of the goods, services, facilities, privileges, advantages, and accommodations of any place of public accommodation, as defined in this section, without discrimination or segregation on the ground of race, color, religion, or national origin.

(b) ESTABLISHMENTS AFFECTING INTERSTATE COMMERCE OR SUPPORTED IN THEIR ACTIVITIES BY STATE ACTION AS PLACES OF PUBLIC ACCOMMODATION; LODGINGS; FACILITIES PRINCIPALLY ENGAGED IN SELLING FOOD FOR CONSUMPTION ON THE PREMISES; GASOLINE STATIONS; PLACES OF EXHIBITION OR ENTERTAINMENT; OTHER COVERED ESTABLISHMENTS Each of the following establishments which serves the public is a place of public accommodation within the meaning of this subchapter if its operations affect commerce, or if discrimination or segregation by it is supported by State action:

(c) OPERATIONS AFFECTING COMMERCE; CRITERIA; "COMMERCE" DEFINED

The operations of an establishment affect commerce within the meaning of this subchapter if (1) it is one of the establishments described in paragraph (1) of subsection (b); (2) in the case of an establishment described in paragraph (2) of subsection (b), it serves or offers to serve interstate travelers of a substantial portion of the food which it serves, or gasoline or other products which it sells, has moved in commerce; (3) in the case of an establishment described in paragraph (3) of subsection (b), it customarily presents films, performances, athletic teams, exhibitions, or other sources of entertainment which move in commerce; and (4) in the case of an establishment described in paragraph (4) of subsection (b), it is physically located within the premises of, or there is physically located within its premises, an establishment the operations of which affect commerce within the meaning of this subsection. For purposes of this section, "commerce" means travel, trade, traffic, commerce, transportation, or communication among the several States, or between the District of Columbia and any State, or between any foreign country or any territory or possession and any State or the District of Columbia, or between points in the same State but through any other State or the District of Columbia or a foreign country.
