Comes now the Palm Beach County Jural Assembly, having been lawfully reestablished on October 20, 2020 declares as follows this

Writ of Instruction

Whereas, the Founders of our country stated in our Declaration of Independence "That to secure these rights, governments are instituted among men, deriving their just powers from the consent of the governed."; and,

Whereas, in order to maximize the freedom of We The People, and to create a government of, by and for We The People, the founders of our country created a form of limited government called a Republican form of government as guaranteed in Article 4 Section 4 of the Supreme Law of our Land, the Constitution for the United States; and,

Whereas, in a Republican form of government, all political power is inherent in the People as stated clearly in Article 1 Section 1 of the Constitution of the State of Florida; and,

Whereas, Florida is a Common Law state as written in Florida Statute 2.01; and,

Whereas, all Public Servants must swear or affirm an Oath of Office to support and defend both the Constitution of the United States and the Constitution of the State of Florida; and,

Whereas, there exists no delegated authority to any entity of our government in either constitution to mandate the people wear masks of any kind; and,

Whereas, our public servants implement any rule, ordinance, statute, emergency order without any explicitly delegated authority, such an action is null and void ab initio; and,

Whereas, all authority to any government entity must be explicitly delegated in written form in one or both constitutions or else the authority is not delegated and remains with We the People; and,

Whereas, multiple scientific studies of the health impact of wearing masks prove that masks are not effective means of protecting the health of people against viruses that are much smaller in size than the holes of typical masks; and,

Whereas, in a meeting held on May 20, 2021 We the People on the land of Palm Beach County in Jural Assembly did approve a Resolution authorizing this Writ of Instruction to be delivered to the Palm Beach Board of County Commissioners, the Palm Beach County Sheriff, the County Administrator, the Palm Beach County Director of the Board of Health, the School Board of the School District of Palm Beach County, and the Superintendent of the School District of Palm Beach County in accordance with Article 1 Section 5 of the Florida Constitution, which reads as follows

"The people shall have the right peaceably to assemble, to instruct their representatives, and to petition for redress of grievances."; and,

Therefore, each member of the Palm Beach County Board of County Commissioners and the members of the School Board of The School District of Palm Beach County are hereby lawfully instructed to vote, on or before May 28, 2021, to rescind, revoke, and/or terminate any and all mandates, rules, ordinances, emergency orders, any other mechanism does or intends to require, that the people, their property or their offspring on the land of Palm Beach County to wear a mask of any type at any time in public.

And, the Sheriff of Palm Beach County and all other law enforcement officers within Palm Beach County borders, including but not limited to all police and all Deputy Sheriffs are instructed hereby to terminate all law enforcement actions regarding the enforcement of any unconstitutional and unlawful mandates for anyone to wear masks anywhere in public within the borders of Palm Beach County.
