## **Writ of Instructions**

Dear Sheriff Bradshaw,

On behalf of the Palm Beach County Jural Assembly (PBCJA), we respectfully requested a meeting with you to be held at your earliest convenience no later than December 8, 2021 to begin a very critical dialogue regarding our county and The People's Constitutional Rights – your office did not contact us to set up the meeting. Due to your lack of response we are following up now with a Writ of Instructions.

As you know, Florida is a common law state. That means that the US Constitution and Florida Constitution are the supreme laws of our state.

As you remember, you sworn an Oath of Office to uphold and protect the Constitutions (*Exhibit A – Palm Beach County Sheriff Rick Bradshaw Oath of Office*):

“ I do solemnly swear (or affirm) that **I will support, protect and defend the Constitution and Government of the United States and State of the Florida**, that I'm duly qualified to hold office under the Constitution of the State, and that **I will well and faithfully perform the duties of Sheriff** on which I'm now about to enter, so help me God.”

As a long time law enforcement officer, you should know how imperative it is to uphold and defend the integrity of the US Constitution in Florida. It does not go unnoticed that you have failed in upholding and violated your own sworn Oath of office.



All local elected public servants **work for The People** and do not rule the People. (*Exhibit B – Palm Beach County organizational chart*).

Today, the local sheriff is elected by The People of his/her county. The Sheriff is the highest local Constitutional officer; a representative of The People. The duty of the Sheriff is to protect the rights of The People from all unlawful acts; even when those unlawful acts are by the government itself. If the Sheriff allows criminal acts to be perpetrated on The People, **he/she is derelict in his/her duties**.

As you are aware, a whistleblower revealed that the FBI created threat tags to track alleged menacing statements made against school boards and their members after U.S. Attorney General Garland directed the bureau to take the lead on what they call hyper-local disputes. Not only is the FBI targeting parents but they are targeting election officials who dare to question voter integrity in their 2020 elections. On 11/17/21, the FBI raided the home of Mesa County Clerk, Tina Peters, who was investigating an election data breach. On 11/19/21, the FBI Special Weapons and Tactics (SWAT) team, along with state and local authorities, raided the home of Sherona Bishop. She is a single mother who runs the America's Mom platform dedicated to parents' education on Colorado legislation concerning public schools.

Similarly, in our own county, just as egregious acts have been taking place over last year and half. For example at a PBC school board public meeting the father with a bad back who was tackled down to the ground for simply standing to relieve his chronic back pain. In a case of another father, even after following the orders to leave the masked room for the unmasked room he left the building and was maliciously tackled to the ground and arrested by 4 PBC school board police officers.

These are two examples of arbitrary rules and unlawful arrests.

This is where our conversation with you begins. We expect that our Sheriff will help to protect our homes, our property, our life and our family from the acts of those who would violate our rights, including law enforcement. We The People are being unjustly targeted, harassed, and humiliated and we see no presence by our county Sheriff to intervene.

Therefore, We The People are issuing you a Writ of Instruction to meet with us and sit down to discuss a plan of action to restore our Constitutional Rights and address these acts of selective bullying and harassment at the local and the highest levels of our government.

It is the Sheriff that we rely on to defend our rights to peacefully assemble and to protect our freedom of speech. We recognize that as the electorate we are at the top of pyramid of power in our county. Your office answers to us The People. (*Exhibit B – Palm Beach County organizational chart*).

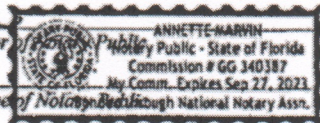
