Writ of Instructions

Dear Sheriff Ric Bradshaw,

On behalf of the Palm Beach County Jural Assembly (PBCJA), we respectfully ask that your office open an investigation into the Supervisor of Elections, Wendy Link and the THOUSANDS OF ELECTION VIOLATIONS that occurred in last three (3) elections (2020, 2021 and 2022) found and reported to you by Jeff Buongiorno.

Tampa Free Press: "Jeff is the president and CEO of a tech company, that specializes in analytics, complex database integrations, and financial technology specializing in servicing the 'Made to Order' manufacturing sector and encumbrance accounting for local government/public sector. What he discovered on the local level is equally astonishing as what was discovered on the national level.

He found over 9,700 reporting violations of Florida election code (FL Statute 98.0981 2A). The law requires that the Supervisor of Elections of Office must itemize the vote count, by contest, by candidate, and by vote type (type-by mail, day of, Early, and provisional).

There were many reporting violations in the democrat primary between McCormick and Holness for the special FL CD 20 election. On Dec 5th, 2021, the Sun-Sentinel reported that the voters of Palm Beach County should be angry. The trend persisted in the March 8th municipal election with about 400 reporting violations.

The people of Congressional District 21 delivered over 100 affidavits requesting a full forensic audit on Feb 9th, 2022.

The people of Congressional District 21 have placed calls with the Palm Beach County Sheriff's Office asking for legal action. "

2020 General Election Reporting violations=9,723 violations 20 percent + of lines reported are in violation of 98.0981.

Threat Surface- Reporting violations

- Trend of reporting violations identified. 3rd degree misdemeanor.
- Trend of lack of transparency continues from 2020 through current elections.
- PBC Sheriff is unwilling to take action complete per his office.
- The detail of reporting is critical.
- Accurate reporting is critical to election integrity.
- The current level of reporting would not be tolerated by the private sector, The People of PBC should tolerate this trend.

Malfeasance:

104.101 Failure to assist officers at polls.—Any person summoned by the sheriff or deputy sheriff who fails or refuses to assist him or her in maintaining the peace at the polls is guilty of a misdemeanor of the first degree, punishable as provided in s. 775.082 or s. 775.083.

104.11 Neglect of duty by sheriff or other officer.—Any sheriff, deputy sheriff, or other officer who willfully neglects or willfully refuses to perform his or her duties relating to elections is guilty of a misdemeanor of the first degree, punishable as provided in s. 775.082 or s. 775.083.

104. [No Title] Intermingling ballots.—Whoever willfully places any ballot in the ballot box except as properly voted by electors, or willfully intermingles any other ballots which have not been duly received during the election with the ballots which are voted by the electors, is guilty of a felony
